



**MWROC 2014 CODE OF CONDUCT PARTICIPATION AGREEMENT**

It is important that the camper (and parent/guardian if applicable) recognizes that MWROC is a camp that is open to ages 12 and up. While at the camp, you will be surrounded by adult faculty, staff, and fellow participants; however, **individual supervision is minimal**. Each camper must be mature enough to be responsible for his or her own behavior. If there is ANY question or doubt as to a camper's ability to conduct him/herself in an adult manner, **please consider registering a guardian to attend the camp with that person.**

To ensure that every camper's experience is a positive one, we ask that you abide by the following Code of Conduct:

- Absolutely NO DRUGS, ALCOHOL, TOBACCO, GAMBLING, FIREWORKS, FIREARMS, or other WEAPONS will be allowed on campus. Any person breaking this rule will be immediately DISMISSED WITHOUT REFUND or hesitation. All University and city laws will be enforced. The entire campus is NON-SMOKING.**
- Campers 17 & under are required to attend ALL classes and concerts.** In addition to these activities being the primary focus of the week, it is extremely important that we are able to locate campers quickly in the event of an emergency. If, for any reason (i.e., illness, emergency, etc.), a camper is not able to attend a scheduled class or event, he/she **MUST notify a staff member immediately.**
- All camp participants are **required to wear their name badge in a visible manner at ALL times.** Not only does this help the faculty and staff to identify them, but the badge also serves as their meal ticket. It also assists in the identification of any non-camp persons for obvious security reasons.
- Campers 17 & under are not allowed under ANY circumstances to leave the campus.** All vehicle keys will be collected at check in and kept in the MWROC office. In the event of an emergency, campers should locate the nearest faculty or staff member.
- Campers 17 & under are REQUIRED to sign-in with the staff** at the following times (all times are subject to change):
  - 8:00 am Prior to their first class
  - 7:00 pm Prior to the evening concert at Bell Center
  - 10:00 pm Evening curfew at the dormitory

All campers **17 & under MUST** be present at **EVERY SIGN-IN**. If you do not sign in, a staff member will be required to locate you. **Our primary concern is your well being, and your cooperation is necessary to ensure your safety.** If you miss more than one sign-in, you could be asked to leave the camp.

- All campers are expected to behave in a respectful, responsible, and courteous manner toward faculty, staff, fellow students and University personnel at ALL times.

If it is brought to our attention that a camper is unable to abide by this Code of Conduct, we reserve the right to send the participant home immediately without refund or hesitation at their expense (using the CC placed in file with application). **MWROC reserves the unrestricted right to dismiss any camper whose conduct is unsatisfactory or inimical to the Camp's best interest without any tuition refund. We accept absolutely NO responsibility for any behaviors in which they may engage that are destructive or that endanger themselves or others.**

By signing this form, I agree that I have read and fully understand all of the above information. I understand that all policies stated above will be enforced and applied. I further agree and understand that if I, the camper, fail to comply with the above policies, I will be dismissed without refund.

**REQUIRED PARENT-GUARDIAN CONSENT & ASSUMPTION OF RESPONSIBILITY FOR CAMPERS 17 AND UNDER**
